<p>On September 30, the California Energy Commission will discuss adoption of the 2022 California Green Building Standards Code Voluntary Residential Energy Efficiency Measures and other energy references. The proposed amendments to the 2022 California Green Building Standards Code will increase the number of available prerequisite options that encourage specific design strategies or technologies and clarify the recommended Energy Design Rating targets for California Climate Zones 1 through 16, necessary for residential buildings to comply with the voluntary energy provisions of Part 11. The proposed amendments to the 2022 Building, Plumbing, Electrical and Mechanical Codes provide references that inform readers of requirements in the 2022 Energy Code applicable to the same building systems or components.</p>

<p>This bill would require the Energy Commission to develop and publish on its internet website a guide for electrification of buildings and to submit to the Legislature a report on barriers to electrifying existing buildings and to adding energy storage or vehicle charging equipment to existing buildings.</p>
