<p>The International Association of Plumbing and Mechanical Officials (IAPMO) and the Medical Gas Resiliency Task Group are seeking public input for the development of a Manual of Recommended Practice for Medical Gas Resiliency. This manual aims to provide code-enhanced language for medical gas piping systems, focusing on resilience and innovation, with a strong emphasis on ensuring the availability and effectiveness of medical gases in healthcare facilities. It's designed to be easily adopted and codified by building and health departments and includes insights from industry experts.</p>

<p>This bill would facilitate the conversion or redevelopment of commercial properties into housing, including adopting adaptive reuse ordinances or other mechanisms that reduce barriers for these conversions to prohousing local policies. The bill directs the Department of Housing and Community Development to convene a working group no later than December 31, 2024, to identify challenges to, and opportunities that help support, the creation and promotion of adaptive reuse residential projects. They will recommend amendments to state building standards and report their findings by December 31, 2025.</p>
