<p>The Washington State Building Code Council is holding two public hearings to hear public testimony on proposals to the Commercial and Residential Energy codes addressing the possible federal Energy Policy and Conservation Act (EPCA) of 1975 preemption (42 U.S.C. § 6201 et seq.) based on the recent U.S. Court of Appeals for the Ninth Circuit ruling in CRA vs. City of Berkeley. The first hearing is November 21st at the Yakima City Hall, and the second hearing is scheduled for November 22nd, 2023 at the DES Building in Olympia.</p>

The Board of State Examiners of Plumbers and Gas Fitters will conduct a public hearing to discuss proposed amendments to the Uniform State Plumbing Code (248 CMR 10.00) on November 17, 2023, at 11:00 a.m. in Boston, Massachusetts. The amendments aim to clarify requirements, remove redundancies, accommodate modern plumbing methods and materials, define minimum plumbing fixture standards, and introduce non-gender designated multi-user bathrooms.
