The North Carolina Building Code Council is conducting a rule-making proceeding and public hearing to incorporate changes in various building codes, including the Building, Electrical, Energy Conservation, and Fire Codes, among others. The proposed changes will reflect updates resulting from rule-making petitions and Council proposals, with a public hearing scheduled for September 10, 2024, and comments accepted until October 14, 2024. Notable changes include amendments to the 2018 and 2024 NC Building Codes to reinstate 2009 standards for piers and docks in estuarine waters and updates to insulation requirements for unvented attic and enclosed rafter assemblies.


During the Ohio Residential Construction Advisory Committee meeting on July 17th, changes to 2024 IRC Chapters 4-8 were presented and accepted unanimously after discussions, with draft rule preparations to address noted items. Recommendations were made to adopt selected IRC appendices for alternative construction standards, like tiny homes, and IRC plumbing chapters as an alternative compliance path, with no opposition from the committee. It was also highlighted that the Federal Housing Administration (FHA) will require compliance with the 2021 International Energy Conservation Code (IECC) for mortgage funding, indicating its significant role in future residential construction standards.




