





Summary: The Maine Uniform Building and Energy Code (MUBEC) sets the rules for building construction across Maine, aiming to create consistent standards statewide. The code is established by the Technical Building Codes and Standards Board and includes various guidelines from the International Energy Conservation Code (IECC) and standards from the American Society of Heating, Refrigerating and Air-Conditioning Engineers (ASHRAE). Key elements include energy conservation and ventilation standards for both residential and non-residential buildings. The 2021 IECC and the 2019 editions of ASHRAE's standards for indoor air quality and energy efficiency are incorporated.
