<p>During the July 26, 2024 meeting, the NYS Fire Prevention and Building Code Council discussed updates to the Uniform Code and Energy Code, with a focus on adopting the 2024 ICC model codes, incorporating New York-specific amendments, and including provisions from NYStretch 2020. The council approved motions to proceed with the SEQR process, designating themselves as the lead agency for environmental review, and noted that the earliest opportunity for code adoption would be in March 2025. Public comments on the Notice of Rule in Development (NRD) will be accepted until September 24, 2024, with the final draft documents for the codes already posted on the Division's website.</p>

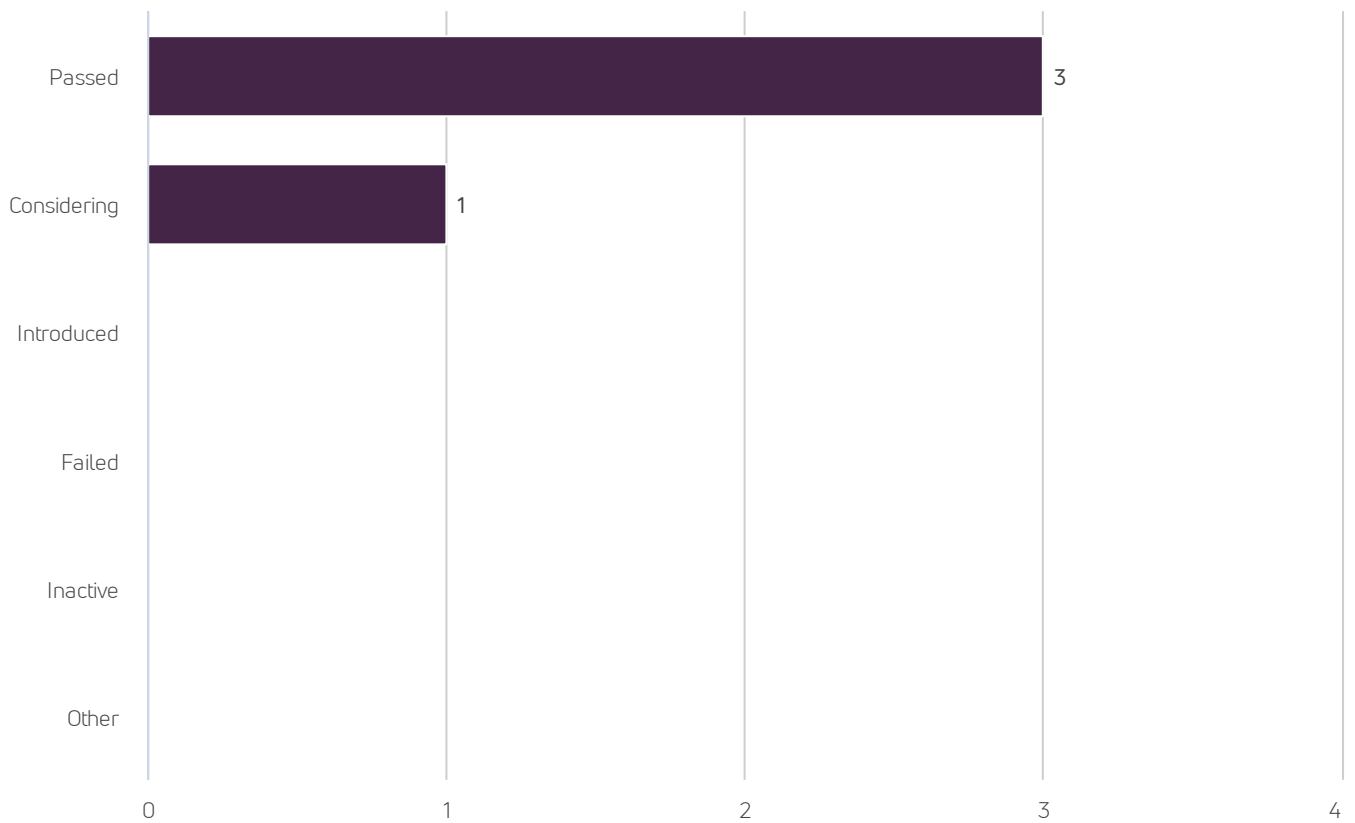

New business includes a proposal to repeal section 46-19.8 of the Hawaii Revised Statutes, enabling counties to set their own residential fire sprinkler requirements.</p>

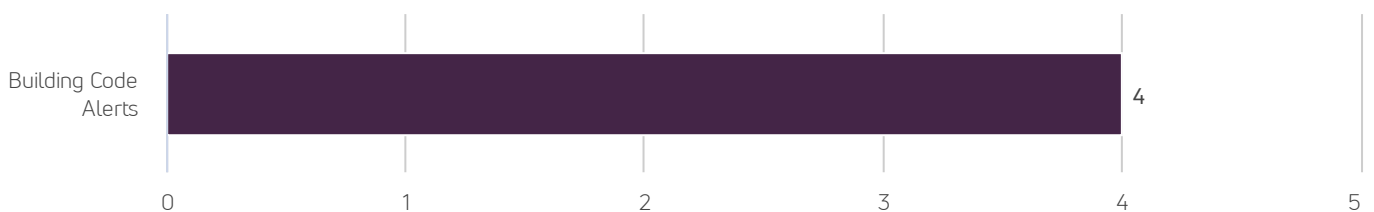

### Number of Bills Per Issue

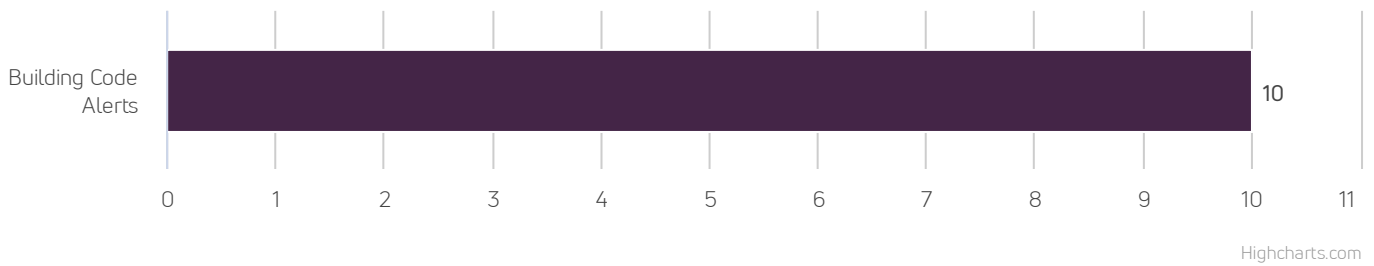

# Number of Regulations Per Issue

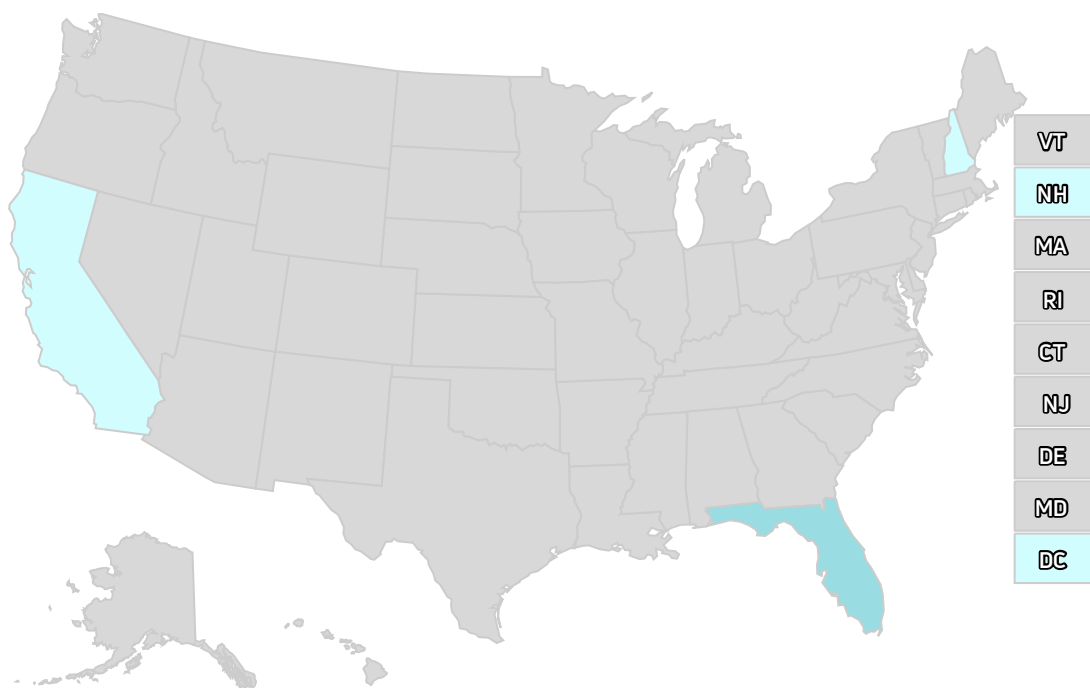

### CA SB 1152

**Title:** State Fire Marshal: fire safety: regulations: lithium-based battery systems: telecommunications infrastructure.

**Current Status:** Considering

**Introduction Date:** February 14, 2024

**Last Action Date:** August 7 set for first hearing. Placed on suspense file.. August 07, 2024

**Summary:** This bill focuses on fire safety regulations for lithium-ion batteries in California. The bill requires the State Fire Marshal to propose updates to the fire standards for lead-acid and nickel-cadmium battery systems to also include identical requirements for lithium-ion batteries. These updates must be proposed before the next triennial edition of the California Building Standards Code adopted after January 1, 2025. The Legislature intends that no additional requirements, beyond those described in the bill, are included in the updated battery requirement regulations.

## NH HB 1065

**Title:** relative to fire sprinkler requirements in residential buildings.

**Current Status:** Passed

**Introduction Date:** November 27, 2023

**Last Action Date:** Signed by Governor Sununu 08/02/2024; Chapter 324; 10/01/2024 HJ 16. August 07, 2024

**Summary:** This bill amends State Fire Code and Rules providing that fire suppression or sprinkler systems are not required in existing residential buildings with no more than 4 dwelling units if the building is in compliance with the state fire code including, but not limited to fire barriers, dedicated ingress and egress or secondary means of escape with emergency rescue openings and monitored fire alarm systems.

**Title:** Green Housing Coordination Temporary Amendment Act of 2024

**Summary:** This bill inserts net zero energy requirements for large residential and mixed-use construction projects receiving Fund assistance; the Clean Energy DC Building Code Amendment Act of 2022 to require periodic reporting on the development of universal net zero energy building code regulations that will apply to residential and mixed-use construction; and the Green Building Act of 2006 to remove those net zero energy compliance provisions inserted by the Greener Government Buildings Amendment Act of 2022 that apply to residential and mixed-use projects.
