The Minnesota Construction Codes Advisory Council meeting agenda highlights Minnesota's ongoing building code adoption process, including updates on proposed revisions to Minnesota Rules Chapters 1300-1346, covering areas such as energy, mechanical, and accessibility codes. The Commercial Energy Code TAG is exploring the adoption of the 2022 ASHRAE 90.1 standard with addenda. Separately, the Technical Advisory Groups (TAGs) are reviewing the 2021 and 2024 International Codes against Minnesota's 2018 amendments, recommending changes to enhance flexibility for historic buildings, adjust frost depth requirements, and align state rules with the 2024 model codes. Unresolved issues and significant proposals, including editorial changes and concerns about the International Residential Code, are detailed in the appendices.

| | | Tennessee State Fire Marshal Delays 2021 I-Code Adoption, |

The Tennessee State Fire Marshal announced that the adoption of the 2021 I-Codes has been delayed, with the Government Operations Committee expected to review and approve the proposal by February or March 2025, making the codes effective 90 days later. In the interim, the office can grant modifications allowing compliance with the 2021 IBC on a case-by-case basis if strict adherence to current codes is impractical and safety requirements are maintained. The AIA TN continues to advocate for adopting the 2021 I-Codes, emphasizing their importance in enhancing building safety, functionality, and resilience through advancements in technology and practices.

The Oklahoma Uniform Building Code Commission will focus on the permanent rulemaking process for proposed amendments to Title 748 of the Oklahoma Administrative Code. These amendments include updates to several 2024 International Codes: the Building (IBC 2024), Fire (IFC 2024), Residential (IRC 2018), Existing Building (IEBC 2024), Fuel Gas (IFGC 2024), Mechanical (IMC 2024), and Plumbing (IPC 2024) Codes. The Commission will review and potentially approve the draft rule amendments for these codes.



| Washington | 11/14/2024 | TAG Meeting To Discuss Ventilation Code Changes |

The Washington State Building Code Council's Mechanical, Ventilation, and Plumbing Codes Technical Advisory Group (TAG) met virtually on November 14, 2024, to discuss a series of code change proposals. Key items included the review of ventilation system proposals, seismic gas shutoff valve changes, and the introducing of ASHRAE 15 for refrigeration systems. The group also addressed sections of the International Mechanical Code (IMC) related to duct length, return air openings, and refrigerant pipe shafts. Public comment was allowed on each agenda item, and any unresolved proposals were deferred to the next meeting.




Number of Regulations Per Issue
