The meeting invites public input on adopting the 2024 International Residential Code to update Michigan's residential code. Comments may be shared in person at the meeting, or submitted in writing by mail or email by 5:00 p.m. on the same day.</p>

<p>The Florida Building Commission will convene for a plenary session on December 10th, and 11th. The plenary sessions will consist of a review of regular procedural items and updates on the 2023 and 2026 editions of the Florida Building Code, including workplans and findings from recent hurricane damage assessments. The agenda includes decisions on various approvals, including product, entity, accreditor, and course applications, as well as waivers for accessibility requirements. Additionally, the Commission will conduct rule workshops on proposed amendments and recommendations for code updates, address public comments, and set future agenda items.</p>

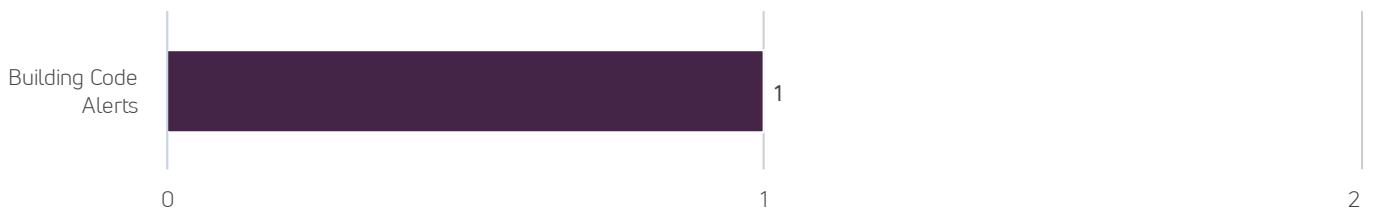

North Carolina	12/10/2024	NC Building Code Council to Review Amendments on Accessibility Standards and Fire Extinguisher Requirements for Specialized Buildings

The North Carolina Building Code Council's upcoming public hearing on December 10, 2024, will review two amendments. The first amendment would delete Section 1108.6.1.2 of the NC Building Code, which currently requires certain accessibility features for Type B units; the change clarifies that these requirements only apply to units occupied for over 30 days. The second amendment to the NC Building Code exempts single-story self-service dry boat storage facilities with locked units and no shared corridors from needing fire extinguishers at every unit, noting that such buildings have minimal occupant load and low escape risk.

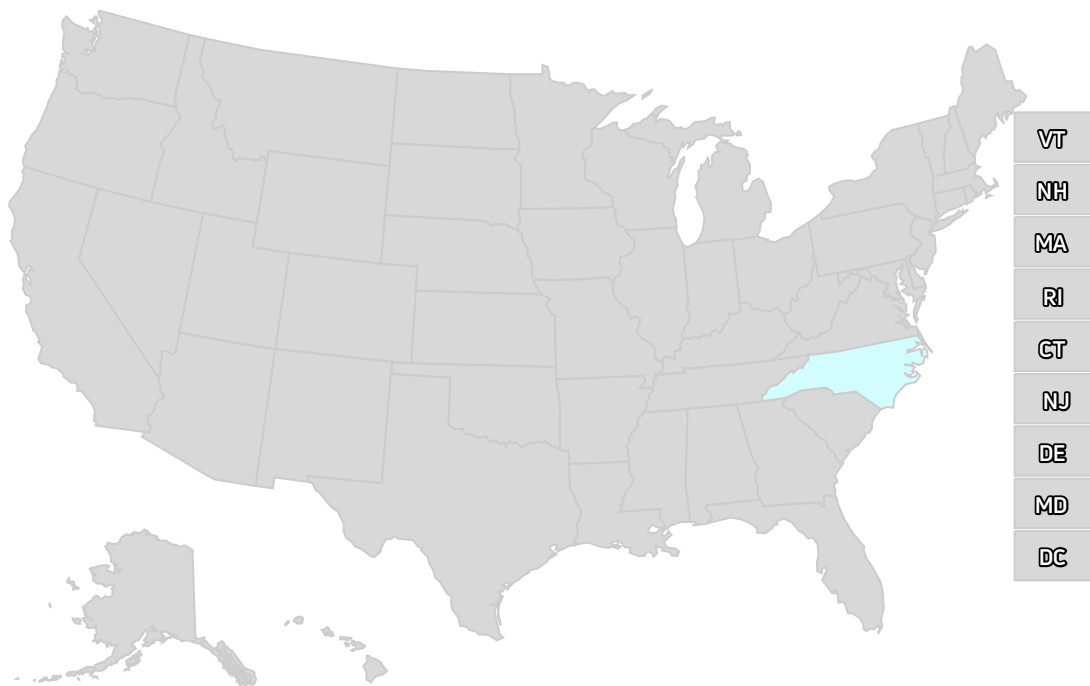

Title: Disaster Relief-3/Budget/Various Law Changes.

Summary: This bill amends the North Carolina Building Code Council appointments. Of the 13 members, one must be a design professional licensed in North Carolina with expertise and experience in the design of structures or buildings subject to the North Carolina Building Code.
