California	12/30/2024	California Building Standards Commission Posts Bulletin on 2024 Legislative Changes to Building Standards Effective 1/1/2025
<p>The California Building Standards Commission has published a bulletin that outlines legislative changes effective January 1, 2025, impacting building standards. Key updates include requirements for childcare centers to update occupancy standards by 2027 (AB 176), extension of deadlines for exterior elevated element inspections to 2026 (AB 2579), and new safety features for pools in licensed childcare facilities (AB 2866). Additional changes mandate updates to rainwater catchment system standards (SB 597), improved accessibility for school facility projects (SB 1091), and new fire safety regulations for lithium-based battery systems and electric mobility devices (SB 1152, SB 1271). These updates reflect efforts to enhance safety, sustainability, and accessibility in building standards statewide.</p>

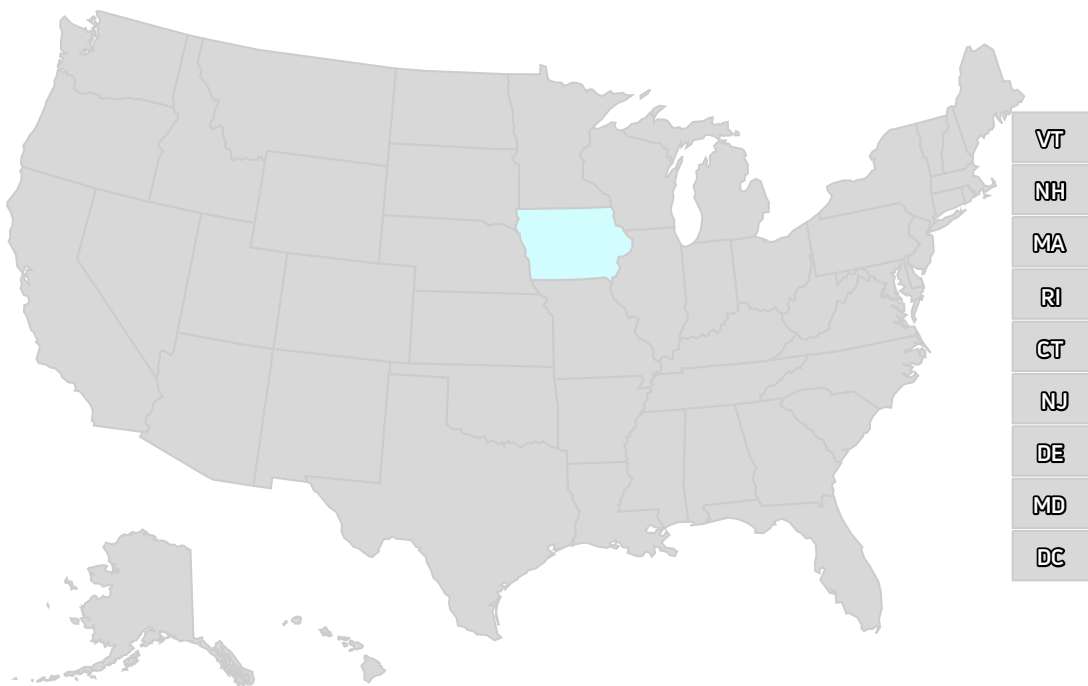
