






#### Number of Regulations Per Issue

#### ILSB 2491

Title: Stretch Energy Code

Current Status: Introduced Introduction Date: February 07, 2025

Last Action Date: Referred to Assignments. February 07, 2025

**Summary:** This bill amends the Energy Efficient Building Act in Illinois to revise the timeline for adopting the Illinois Stretch Energy Code, enhancing energy efficiency in buildings. The Capital Development Board must create and adopt a stretch energy code by December 31, 2026, with specific site energy index targets. Deadlines for subsequent codes have been adjusted for increased efficiency goals by 2032. The code, applicable to projects authorized after July 1, 2024, includes separate components for commercial and residential buildings and emphasizes stakeholder collaboration.

February 07, 2025 Summary: This bill establishes the Illinois Stretch Energy Code to enhance energy efficiency standards for buildings in Illinois. Municipalities can adopt the code for more rigorous requirements for residential and commercial buildings, with deadlines for adoption and energy index targets outlined. Collaboration with the Illinois Energy Code Advisory Council ensures stakeholder input. The initiative aims to boost energy efficiency in construction practices across the state. Location: US-IL

## RI HB 5373

February 07, 2025 Summary: This bill amends the State Building Code in Rhode Island, establishing a standards committee to oversee the adoption of updated building codes. The bill introduces a permit fee structure to fund electronic permit systems and contractor training.

The bill establishes that counties may amend these state building codes within their jurisdictions, but they can only do so by removing requirements or adding new ones with prior approval from the council. Additionally, the bill repeals the previous authority of counties to adopt, amend, and update the Hawaii state building codes independently.

The board must adopt rules implementing regional building code recommendations from the advisory committee that account for local climatic and geographic conditions for the construction and installation of factory-built structures, which supersede any conflicting ordinance, code, regulation, or other law of a local government unless the local government adopts the rules of the board, covering the implementation requirements developed by the advisory committee, covering electrical, plumbing, or fire suppression activity required to undertake or complete the construction or installation of a factory-built structure, and allowing the division to contract for third-party review and approval of a final design plan for a factory-built structure on behalf of the division. **Location:** US-CO

February 05, 2025 Summary: This bill amends Tennessee Code Annotated, Title 68, Chapter 120, by adding a new subsection to Section 68-120-101. If appealed, the local Building Code appeals board may grant more time, but if no appeal is filed or the extension expires, the unsafe designation will resume, and the locality may continue with demolition procedures if necessary. **Location:** US-VA

**Summary:** This bill amends the responsibilities of the State Building Code Council. The proposed changes include requiring the council to conduct financial analyses of new codes and standards, determining which codes are essential for public safety, and consulting with industry stakeholders to gather insights on construction practices and cost implications. The council will also be tasked with making timely recommendations to county governing bodies regarding the adoption of updated codes, with a two-year timeline for these recommendations.

#### Introduction Date: February 04, 2025

**Last Action Date:** Read for the first time and referred to the House Committee on State Government. February 04, 2025

**Summary:** The bill standardizes building codes statewide by placing adoption authority with the Division of Construction Management and expanding the state building code to include all non-residential buildings. It establishes a process for periodic code updates and allows coastal counties and municipalities to adopt supplemental codes for hurricane and erosion protection. Additionally, it clarifies the scope of architectural practice, the duties of local building officials, and introduces criminal penalties for violations.

Title: Energy-Insulation Req In Homes Current Status: Introduced Introduction Date: January 24, 2025 Last Action Date: Assigned to Energy and Public Utilities. This act would also include a provision for reports to be provided to the governor, the speaker of the house and the president of the senate regarding the nature of the emergency and the number of individuals served by SAVE Units.

#### MD HB 212

Title: Maryland Building Performance Standards - Fossil Fuel Use and Electric-Ready Standards Current Status: Introduced Introduction Date: September 17, 2024 Last Action Date: Hearing 2/26 at 1:00 p.m. (Environment and Transportation) and Hearing canceled (Economic Matters). February 03, 2025 **Summary:** This bill requires the Maryland Department of Labor to update the Maryland Building Performance Standards by mandating that new buildings meet their energy demands without using fossil fuels and comply with electric-ready standards, with phased implementation deadlines based on building height. Waivers for fossil fuel use may be granted for specific building types, such as hospitals and laboratories, under stringent conditions.
