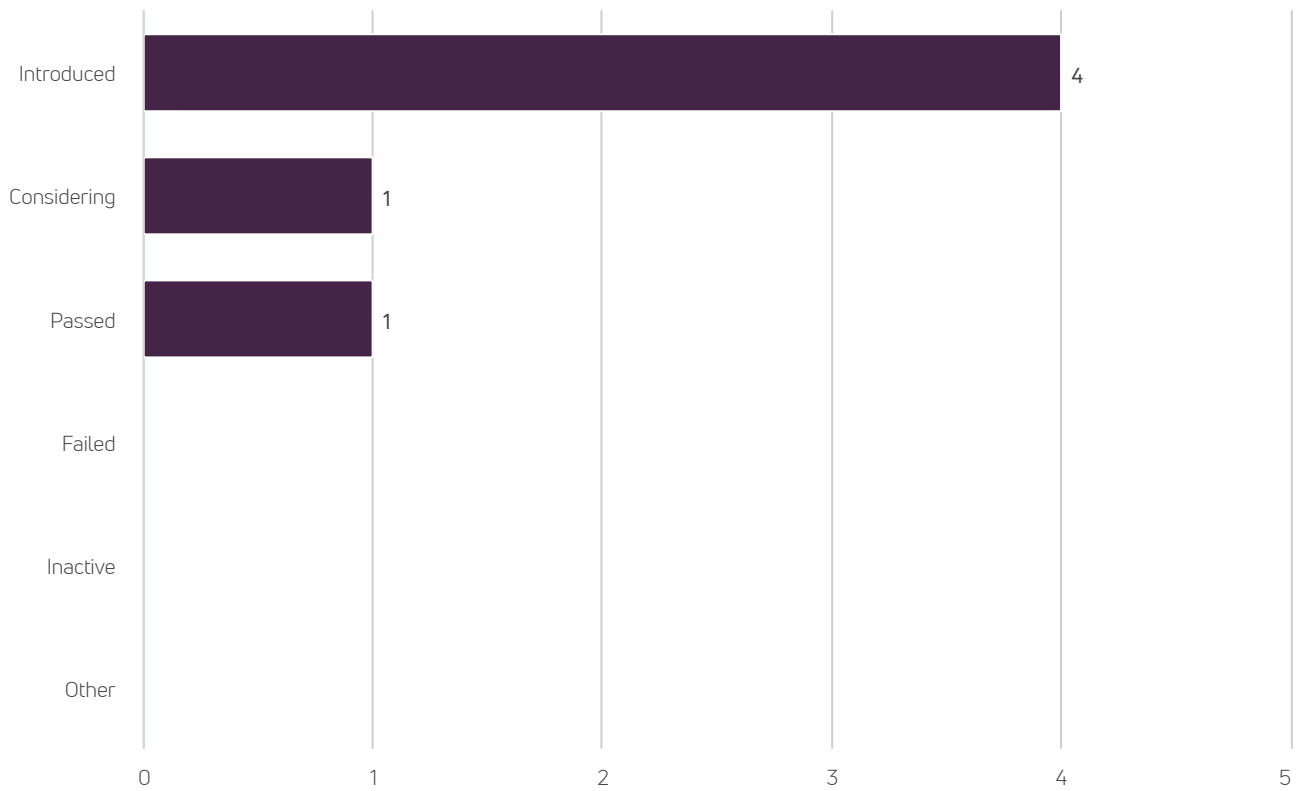

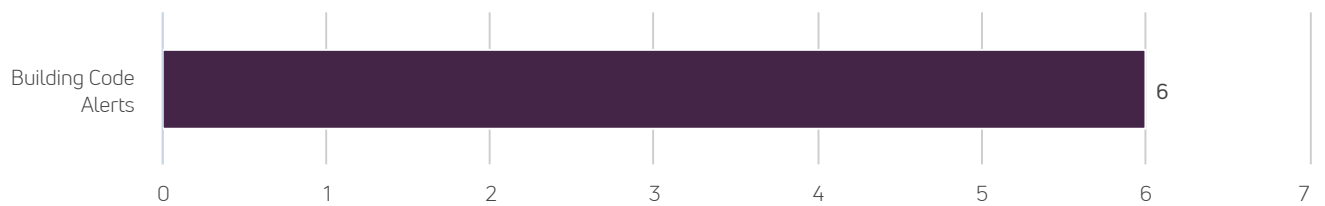

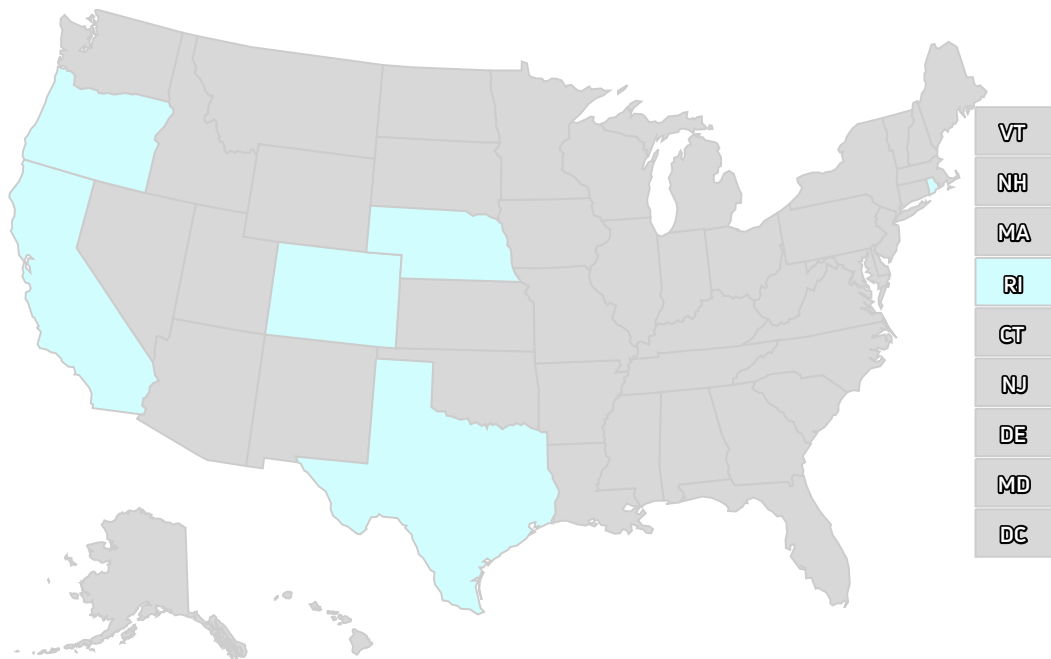

### RI SB 1002

**Title:** An Act Relating To State Affairs And Government -- Rebuild Rhode Island Tax Credit (Amends Provisions Related To The Maximum Project Credit Allowed Under The Rebuild Rhode Island Tax Credit For Certain Qualified Development Projects.)

**Current Status:** Introduced

**Introduction Date:** May 02, 2025

**Last Action Date:** Proposed Substitute. May 30, 2025

**Summary:** This bill would amend provisions related to the maximum project credit allowed under the Rebuild Rhode Island tax credit for certain qualified development projects.

**Location:** US-RI

## TX SB 2835

**Title:** Relating to municipal regulation of stairway requirements in certain apartment buildings.

**Current Status:** Considering

**Introduction Date:** March 14, 2025

**Last Action Date:** Sent to the Governor. May 30, 2025

**Summary:** This bill allows municipalities to permit single-stairway designs in apartment buildings that meet specific safety and design criteria, including limits on height (no more than six stories), unit count per floor, and exit travel distance. The building must also have enhanced fire safety features such as two-hour-rated stairway enclosures, sprinkler systems, emergency escape openings, and occupant notification systems.

## NE LB 531

**Title:** LB531 - Provide an exception to the requirement that buildings constructed with state funds comply with the 2018 International Energy Conservation Code

**Current Status:** Introduced

**Introduction Date:** January 22, 2025

**Last Action Date:** Motion to suspend rules to indefinitely postpone filed. May 30, 2025

**Summary:** This bill amends existing Nebraska statutes related to building codes, specifically concerning the requirements for projects funded by the Affordable Housing Trust Fund. It provides an exception to the mandate that buildings constructed with state funds must comply with the 2018 International Energy Conservation Code. Under this legislation, the Department of Economic Development is prohibited from enforcing compliance with this energy code for new construction or rental conversion projects that receive funding from the Affordable Housing Trust Fund.

## RI SB 1089

**Title:** An Act Relating To Heath And Safety -- State Building Code (Amends The Composition Of The Building Code Standards Committee And Would Make Several Technical Amendments Relative To The Building Code Office And Would Establish A State Building Code Office Within The Office Of State Fire Marshal.)

**Current Status:** Introduced

**Introduction Date:** May 23, 2025

**Last Action Date:** Committee recommended measure be held for further study. May 29, 2025

**Summary:** This bill would amend the composition of the building code standards committee and would make several technical amendments relative to the building code office. In addition, it would establish a state building code office within the office of state fire marshal.

## CA SB 655

**Title:** Residential building standards: indoor temperature.

**Current Status:** Introduced

**Introduction Date:** February 20, 2025

**Last Action Date:** Read second time. Ordered to third reading.. May 27, 2025

**Summary:** This bill mandates updates to California's energy code by requiring the California Building Standards Commission to adopt passive and active cooling strategies to maintain a maximum indoor temperature of 82°F in new residential buildings by July 1, 2026. It also directs the Department of Housing and Community Development to develop a load calculation methodology for heating and cooling in all climate zones. These updates will be incorporated into the next triennial California Building Standards Code update and reported to the Legislature by January 1, 2027.

## OR SB 862

**Title:** Relating to fire protection.

**Current Status:** Passed

**Introduction Date:** January 13, 2025

**Last Action Date:** Governor signed.. May 27, 2025

**Summary:** This bill requires the Department of the State Fire Marshal to adopt a base fire prevention code, known as the Oregon Fire Code, and mandates that this code be made publicly available electronically. It also makes amendments to existing laws regarding fire districts, including provisions for rural fire protection districts. The bill allows fire districts to acquire property for establishing fire evacuation routes and to operate emergency medical services in accordance with county plans.

## 259-009-0005

**Title:** Adopting The 2024 NFPA 1010 Standard For DPSST-Issued Firefighter I And II Certifications

**Type:** Final



**Citations:** 259-009-0005

**Agency:** Department of Public Safety Standards and Training

**Publication Date:** Jun 01, 2025

**Summary:** This regulation maintains the definitions for each of the Oregon DPSST fire service professional certifications. This rule change amends the existing definitions for the NFPA Firefighter I and II certifications (see sections 43 and 44) and adds a definition for NFPA Support Person (see section 67, all subsequent definitions renumbered accordingly). The amendments are based on the adoption of the 2024 Edition of the NFPA 1010 Standard.

## 8 CCR 1507-101

**Title:** Building And Fire Code Adoption And Certification Of Inspectors For Fire & Life Safety Programs Administered By The State Of Colorado

**Type:** Proposed

**Citations:** 8 CCR 1507-101

**Agency:** Department of Public Safety

**Publication Date:** May 26, 2025

**Summary:** This proposed rule aims to update the title of building inspectors certified by the Division to perform delegated inspection services in alignment with Article 10.1 of 8 CCR 1507-30; to adopt the 2023 edition of the Colorado Model Electric Ready and Solar Ready Code as required by Colorado HB 22-1362; and to update definitions, update formatting for accessibility, and to correct grammatical and formatting errors.
